

**Board of Education Meeting  
October 22, 2007**

The Board of Education of the Findlay City Schools met in regular session at 7:00 p.m. in the Gymnasium at Jefferson Primary School.

President Brown called the meeting to order. Present were: Mrs. Brown, Mrs. Dysinger, Mrs. Rothery, Mr. Shrader, Assistant Superintendent Blaine and Treasurer Barnhart.

**CELEBRATIONS**

Thank you to Sauder Furniture for their donation of furniture and shipping costs to furnish Administrative offices. Congratulations to FHS Quiz Bowl team for being 16-0! Congratulations to the freshman football team on a successful season. An outstanding job by FHS teachers and students – 45 AP Scholars. Congratulations to the boys' cross-country team for going to regionals.

**PUBLIC PARTICIPATION**

FEA President Dee Groman thanked *The Courier* for their coverage of school events; acknowledged Lincoln school has been named a School of Promise, which is the only school in the area to be named; noted the end of the grading period will end on November 2; offered appreciation and thanks to those who have generously donated gifts to district; and said the first roundtable for teachers and administration will be held on October 30.

Gary Kapostasy, Vice-President of FEA, spoke to the board regarding HB 315, STRS Health Care. He requested the board's support of this bill.

Brenda VanDeKoppel, parent of two high school seniors, indicated she had received a letter from Dr. Wittwer regarding her past questions about add-on credits but still has some unanswered questions. She would like to see a document that answers all of the questions parents may have about the add-on credits.

Mike Wallace, Principal of Jefferson Primary School, welcomed board members, school employees and community members to Jefferson. The school has recently moved to grade levels except for one multi-age classroom. Mr. Wallace spoke highly of the involvement and dedication of Jefferson's teaching staff, highlighting their individual accomplishments. Kay Sidle and Rebecca Wank introduced Jefferson and Chamberlin Hill Schools' new therapy dog, Jewels. They also thanked the board for their support of applying for and receiving Jewels.

**CORRESPONDENCE**

Mr. Barnhart presented an article to the board from a recent STRS newsletter that spoke about House Bill 315. If passed, this legislation will lead to additional contributions by the board and employees to the retirement system to pay for its health care costs for retirees. The cost to the Board would amount to over \$812,500 per year if House Bill 315 passes. Mr. Barnhart suggested that the board send a letter to the 15 sponsors of the bill explaining that the bill will cost too much. A similar letter was sent to local legislators and the governor in February.

### BOARD'S COMMENTS

Mrs. Rothey appreciated David Coolidge returning to Findlay for the Alumni Concert; offered congratulations to Peggy Kirk Bell who was honored as a Distinguished Alumni; thanked administration for creativity in request submission to the Emergency Assistance Fund; appreciated Mr. Kapostasy's comments regarding House Bill 315, however wishes to resend February 2007 letter to sponsors of this bill asking them to reconsider their support.

Mrs. Dysinger asked the board to create tribute or resolution for all of the staff's hard work during the flood.

Mr. Shrader said the FEMA application is in but we still need to present documents; the process of determining what needs to be replaced and what can be salvaged continues; thanked Mr. Kapostasy for his comments related to STRS but said we have to look at costs from a school board perspective; noted Veteran's Day programs at schools in upcoming weeks – challenge board to attend; and thanked those who have donated monetary gifts as well as furniture and furnishings.

Mrs. Brown noted Challenge Day is coming up and encouraged all to attend and she would like to see it fully integrated and funded by the district.
